INFORMED CONSENT/GENERAL RELEASE OF LIABILITY

*This is a release of liability. Please read carefully before signing.*

**Since participation in youth sports activities can be dangerous, the Peoria Notre Dame Youth Baseball League (PNDYBL) requires that all participants and their adult parent(s) or legal guardian(s) assume all risks associated with youth baseball by signing this general release.**

being permitted to participate in **PNDYBL** youth baseball activities, I hereby voluntarily release, discharge, waive and relinquish any and all claims or actions for damages for personal injury, permanent disability, death, or property damage arising out of or relating to participation in or attendance at youth baseball activities or for any other reason. This release is intended to discharge, in advance, **PNDYBL**, its officers, employees and agents, and the owners and maintainers of any facility used for baseball or other activities, from any and all liability arising out of or connected in any way with my child's participation in all baseball or other activities including, without limitation, any baseball camp, clinic, evaluation or tryouts, even though that liability may arise out of negligence or carelessness on the part of **PNDYBL**, its officers, agents or employees, or the owners or maintainers of any facility used by **PNDYBL** for baseball or other activities.

I further understand that serious accidents occasionally occur during youth baseball activities and that participants and attendees occasionally sustain serious personal injuries, death or property damage as a consequence thereof. Knowing the risks, I hereby voluntarily sign my child up and apply for my child to participate in all **PNDYBL** activities and hereby agree to assume all risks and hereby agree to forever release and hold harmless **PNDYBL**, its officers, employees or agents, and the owners or maintainers of any facility used by **PNDYBL** for baseball or other activities, from and against any and all claims, liabilities, losses, damages, causes of action, costs and expenses, including without limitation reasonable attorney's fees and court costs.

I further understand and agree that this release, discharge, waiver, and assumption of risk is to be binding on my and my child's heirs, executors, administrators, and assigns.

I agree to comply with all **PNDYBL** rules and regulations, bylaws and such other terms and conditions for participation according to the **PNDYBL**.

I have read this Informed Consent/General Release of Liability fully understanding its terms that I give up substantial rights by signing it, and I sign it voluntarily.
